

## BYLAW NO. 1-2015

A BYLAW OF DUNDURN RURAL WATER UTILITY WHICH PROVIDES FOR FIXING THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER

---

THE Board of the Dundurn Rural Water Utility, in the Province of Saskatchewan enacts as follows:

1. **THE** charges to be paid by the water consumer shall be those set out in Schedule "A" attached.
2. **THE** Schedule attached and marked "A" shall take effect in all respects as Schedule "A" to Bylaw No. 1-2015.
3. **THAT** the monthly maintenance fee, prorated for the period of connection during the month, shall be payable in every case whether or not any water is consumed once water is available.
4. Accounts for water service shall cover a period of three successive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of forty-five days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$200.00 to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employee's regular working hours, the fee shall be \$350.00.
5. A penalty of two percent (2%) per month (26.8% per annum) will be added to all water accounts outstanding about the 1<sup>st</sup> day of each month following each billing period.
6. Bylaws No. 3-2011 and 1-2014 are repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or January 1, 2015, whichever is the latter.
